**Insolvency of StreamView GmbH, FN 512989x
Case No. 6 S 56/26s, Vienna Commercial Court**

Dear Sir or Madam,

by order of the Vienna Commercial Court dated 14 April 2026, insolvency proceedings (bankruptcy) have been opened in case no. 6 S 56/26s over the assets of StreamView GmbH, FN 512989x, with its registered office at Franz-Josefs-Kai 1/1st Floor, 1010 Vienna, and Dr. Ute Toifl, Attorney at Law, has been appointed as insolvency administrator. The opening of proceedings became effective on 15 April 2026.

Claims must be filed in the German language exclusively with the Vienna Commercial Court.

A filing fee of **€ 31.00** must be paid to the court's account prior to submitting your claim:

- BIC: BUNDATWW

Please do **not** send emails with invoices, contractual documents, delivery notes, or other supporting documents to the insolvency administrator. **ALL documents must be submitted exclusively to the court.**

Should you file your proof of claim after the claims deadline (**9 June 2026**), an additional fee of **€ 60.00** is payable to the insolvency administrator.

Claims may be filed either directly with the court (a form with completion instructions is available at <http://www.justiz.gv.at>) or – at your own expense – by engaging an attorney or one of the following accredited creditor protection associations:

Creditors whose domicile or place of business is located abroad must designate an authorized recipient for service of process residing in Austria within **14 days** of the publication of the opening of insolvency proceedings in the insolvency register (*Insolvenzdatei*). Failure to do so will result in further documents being served without proof of delivery until a suitable authorized recipient or a domestic address for service is notified to the court. A document is deemed served 14 days after posting. No information regarding a potential dividend payment can be provided at this time.
